Prices may vary depending on event size, location, duration, and requested services.

4. Cancellation Policy

In the event of cancellation by the client, only 70% of the amount paid will be refunded.

The remaining amount will be retained to cover logistics, preparation costs, drink sourcing, staffing arrangements, and other operational expenses already incurred for the event.

Refund processing timelines may vary depending on the payment method used.

TipsyMixerGh reserves the right to decline refunds for cancellations made within a short notice period before the event date.

Clients must provide at least 7 days' notice for rescheduling.

Last-minute cancellations may attract additional charges.

5. Alcohol Responsibility

- Refuse service to intoxicated guests
- Stop alcohol service when necessary
- Request valid identification for age verification

Clients are responsible for ensuring compliance with local alcohol laws and venue regulations.
